

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED THE BOONE COUNTY GOVERNMENTAL AND JUDICIAL CENTER AND AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

<u>Section 1.</u> It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Boone County Governmental and Judicial Center fund. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

Section 2. There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the "Boone County Governmental and Judicial Center" with a fund number of 1804 as assigned by Arkansas Legislative Audit.

Section 3. The following appropriations shall be made from the Revenue Replacement Fund No. 1006:

To: 1804-0100-3060: Governmental & Judicial Center; OS&C; Utilities – Electricity \$5,000.00

To: 1804-0100-3061: Governmental & Judicial Center; OS&C; Utilities – Natural Gas \$5,000.00

To: 1804-0100-3062: Governmental & Judicial Center; OS&C; Utilities – Water \$5,000.00

To: 1804-0100-3100: Governmental & Judicial Center; OS&C; Other Miscellaneous \$35,000.00

(This sum, \$50,000.00, is to be moved into the Boone County Governmental and Judicial Center Fund to cover utilities and normal operating costs of the building that are non-construction related. All construction costs will be taken from the "New Courthouse" Fund No. 4800 as approved with Ordinance No. 2022-14.)

<u>Section 4</u>. If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

<u>Section 5.</u> This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.
