BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED THE OZARK HUMANE SOCIETY GRANT 2023 FUND AND AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2023 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

<u>Section 1.</u> It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Ozark Humane Society Spay and Neuter Grant. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

<u>Section 2.</u> There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the Ozark Humane Society Grant 2023 Fund with a fund number of 3506 as assigned by Arkansas Legislative Audit.

Section 3. The following appropriation shall be made from the OHS Grant 2023 Fund No. 3506:

To: 3506-0306-3100: Ozark Humane Society Grant 2023; OS&C; Other Miscellaneous \$4,500.00

(This is a Spay and Neuter Grant from the Arkansas Economic Development Commission, Division of Rural Services, that we applied for on behalf of the Ozark Humane Society.)

<u>Section 4</u>. If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

<u>Section 5.</u> This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.


