APPROPRIATION ORDINANCE (2)

NO. 2022- 24

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from County General Fund No. 1000:

From: 1000 – County General Fund	\$4,507.31
To: 1000-0400-1005: Sheriff’s Dept; Personal Services; Salaries, Overtime	\$3,622.31
To: 1000-0400-1006: Sheriff’s Dept; Personal Services; Social Security Matching	\$280.00
To: 1000-0400-1007: Sheriff’s Dept; Personal Services; Retirement Matching	\$560.00
To: 1000-0400-1010: Sheriff’s Dept; Personal Services; Worker’s Compensation	\$45.00

**This sum, \$4,507.31, is the total funds received from the FBI for overtime reimbursement and new money for benefit cost for the Ozark Transnational Organized Crime Western Hemisphere (OTOC).*

(The total of \$3,622.31, is money received from Federal Bureau of Investigations as reimbursement for overtime hours worked by Deputy Dayton Evans during December 2021 through April 2022. The difference of \$885.00 will be new money to cover benefits paid on the overtime hours worked. Only overtime wages are reimbursed per the agreement with the FBI and the Sheriff’s Office.)

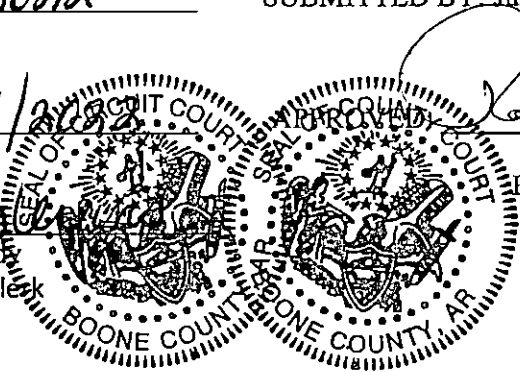
