APPROPRIATION ORDINANCE (3)

NO. 2022- 25

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from County General Fund No. 1000:

(This sum, \$7,643.15, is money received from the Arkansas State Police as reimbursement for the Selective Traffic Enforcement (STEP) Program overtime worked from January – March, 2022. Payment has been received and needs to be appropriated back to the original line items in the Sheriff’s Dept. and Cops in School budgets where the overtime and benefits were initially paid from. Of this total, \$6,046.66 goes back to line item 2002; Small equipment to reimburse the Sheriff’s office radio fund for equipment purchased.)



Section 3. This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.

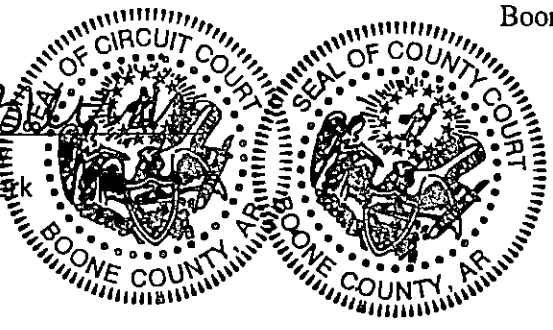
