APPROPRIATION ORDINANCE (2)

NO. 2022- 44

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from County General Fund No. 1000:

From: 1000-0111-3100: County Buildings & Grounds; OS&C; Other Miscellaneous \$8,000.00

To: 4800-0100-4004: New Courthouse; Capital Outlays; Machinery & Equipment \$8,000.00

(This sum, \$8,000.00, is to reimburse the New Courthouse Fund No. 4800 for the purchase of lawn mowers since this fund was solely created to track the expenditures of the renovations and construction costs for the building. All bills for non-construction related costs will now be taken from the Boone County Governmental and Judicial Center Fund No. 1804.)

Section 2. The following appropriation shall be made from the Revenue Replacement Fund No. 1006:

To: 4800-0100-3052: New Courthouse; OS&C; Fire & Extended Coverage \$19,006.85

To: 4800-0100-3060: New Courthouse; OS&C; Utilities – Electricity \$6,207.62

To: 4800-0100-3061: New Courthouse; OS&C; Utilities – Natural Gas \$203.45

(This sum, \$25,417.92, is to reimburse the New Courthouse Fund No. 4800 for the insurance and utility payments made for the new Governmental and Judicial Center. This will reimburse the fund as it was solely created to track the expenditures of the renovations and construction costs for the building. All bills for non-construction related costs will now be taken from the Boone County Governmental and Judicial Center Fund No. 1804.)


Section 3. If any provision or section of this Ordinance is held invalid by a Court of Competent Jurisdiction, such invalidity shall not affect other provisions and sections of the Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.


Section 4. This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.


