BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

**Section 1.** The following appropriation is made from the County General Fund No. 1000:

To: 1000-0109-2024: Election Commission; Supplies; Maintenance & Services	\$7,000.00
To: 1000-0109-3040: Election Commission; OS&C; Advertising/Publications	\$500.00
To: 1000-0109-3094: Election Commission; OS&C; Meals & Lodging	\$1,000.00
To: 1000-0109-3100: Election Commission; OS&C; Other Miscellaneous	\$5,000.00

**Section 2.** The following appropriation is made from the County General Fund No. 1000:

To: 3005-0101-4004: Co Clerk's Cost Fund; Capital Outlays; Machinery & Equipment	\$19,661.00
<b>Section Total:</b>	<b>\$19,661.00</b>
<b>Grand Total:</b>	<b>\$43,161.00</b>

(This sum, \$43,161.00 is the cost(s) of the elections held for the Annual School Election and the Preferential Primary Election that the State/School Districts have paid for.)



**Section 4.** This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.


