APPROPRIATION ORDINANCE (2)

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2023 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from the County General Fund No. 1000:

To: 1000-0108-1001: Courthouse; Personal Services; Salaries, Full-Time	\$4,259.71
To: 1000-0108-1006: Courthouse; Personal Services; Social Security Matching	\$325.87
To: 1000-0108-1007: Courthouse; Personal Services; Retirement Matching	\$652.59
To: 1000-0108-1010: Courthouse; Personal Services; Workers Compensation	\$82.09
TOTAL:	\$5,320.26

(This sum, \$5,320.26, are the additional funds needed to increase the salary of the Maintenance Supervisor position for the county buildings and grounds.)

Section 2. If any provision or section of this Ordinance is held invalid by a Court of Competent Jurisdiction, such invalidity shall not affect other provisions and sections of the Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 3. This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.

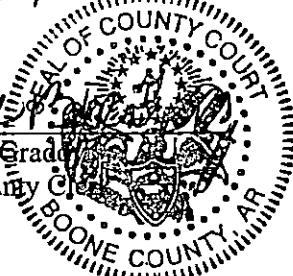
