AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2024 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from the 911 Department Fund No. 3020:

To: 3020-0501-1001: 911; Personal Services; Salaries, Full-time	\$25,720.25
To: 3020-0501-1006: 911; Personal Services; Social Security Matching	\$ 1,967.60
To: 3020-0501-1007: 911; Personal Services; Retirement Matching	\$ 3,940.34
To: 3020-0501-1009: 911; Personal Services; Health Insurance Matching	\$ 2,685.22
To: 3020-0501-1010: 911; Personal Services; Worker's Compensation	\$ 478.71

(This sum, \$34,792.12, is funds received from the City of Harrison for salaries and benefit cost for the three HPD dispatchers paid from the 911 budget during the 4th Quarter, 2023. No new money appropriated.)
