Section 1. The following appropriation shall be made from the County General Fund No. 1000:

To: 1000-0400-1006: Sheriff's Dept; Personal Services; Social Security Matching	\$ 200.52
To: 1000-0400-1007: Sheriff's Dept; Personal Services; Retirement Matching	\$ 401.57
To: 1000-0400-1010: Sheriff's Dept; Personal Services; Worker's Compensation	\$ 48.79

<sup>\*</sup>The total of \$2,621.19, is money received from Federal Bureau of Investigations as reimbursement for overtime hours worked by Deputy Dayton Evans in December 2023, January and February 2024.)

(This sum, \$3,272.07, is the total funds received from the FBI for overtime reimbursement and new money for benefit cost for the Ozark Transnational Organized Crime Western Hemisphere (OTOC))
