APPROPRIATION ORDINANCE (5)

No. 2024 - 24

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2024 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from the County General Fund No. 1000:

To: 1000-0400-1005: Sheriff's Dept; Personal Services; Salaries; Overtime	\$3,815.64
To: 1000-0400-1006: Sheriff's Dept; Personal Services; Social Security Matching	\$291.90
To: 1000-0400-1007: Sheriff's Dept; Personal Services; Retirement Matching	\$584.56
To: 1000-0400-1010: Sheriff's Dept; Personal Services; Worker's Compensation	\$71.02

*The total of \$3,815.64, is money received from Federal Bureau of Investigations as reimbursement for overtime hours worked by Deputy Dayton Evans in March, April, and May 2024.

The difference of \$947.48 will be new money to cover benefits paid on the overtime hours worked. Only overtime wages are reimbursed per the agreement with the FBI and the Sheriff's Office.

This sum, \$4,763.10, is the total funds received from the FBI for overtime reimbursement and new money for benefit cost for the Ozark Transnational Organized Crime Western Hemisphere (OTOC).


