BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AUTHORIZING THE COUNTY COLLECTOR TO PLACE THE FIRE DUES OF THE BERGMAN FIRE ASSOCIATION ON THE PROPERTY TAX STATEMENTS.

WHEREAS, the Rural Bergman Fire Association has made a request of the Quorum Court to place the fire department annual dues for fire protection on the property tax statements as authorized by A.C.A. §14-20-108;

WHEREAS, the Bergman Fire Association has submitted with their request, a petition filed with the County Clerk and signed by registered voters in the volunteer fire department district as authorized by A.C.A § 14-20-108, as amended by Act 693 of 2015;

WHEREAS, the County Clerk has determined that the number of signatures of registered voters in the subject fire district on the petition are sufficient;

WHEREAS, the Quorum Court shall adopt this Ordinance attached to the petition submitted by the registered voters by A.C.A. §14-20-108, as amended by Act 693 of 2015.

NOW, THEREFORE, IT IS HEREBY ORDAINED AND ADOPTED THAT AS PROVIDED BY A.C.A. §14-20-108, AS AMENDED BY ACT 693 OF 2015, THE COLLECTOR SHALL PLACE THE FIRE DUES OF THE BERGMAN RURAL FIRE ASSOCIATION ON THE PROPERTY TAX STATEMENTS. A TRUE AND CORRECT COPY OF THIS ORDINANCE SHALL BE PUBLISHED AS REQUIRED BY LAW AND EFFECTIVE (30) THIRTY DAYS FOLLOWING PUBLICATION.






