BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE APPROVING AND LEVYING COUNTY, MUNICIPAL AND SCHOOL REAL ESTATE TAXES AND PERSONAL PROPERTY TAXES FOR THE YEAR 2024 PAYABLE IN 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following county, municipal, and school real estate taxes and personal property taxes are hereby approved and levied by the Quorum Court of Boone County, Arkansas.
