APPROPRIATION ORDINANCE (1)

No. 2024 - 38

BY BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED HILL TOP GRANT FUND AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2024 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

Section 1. It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Hill Top Volunteer Fire Department Grant funds received from the Arkansas Economic Development Commission, Division of Rural Services, provided through the Arkansas Rural Community Grant Program. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

Section 2. There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the Hill Top Grant Fund with a fund number of 6402 as assigned by Arkansas Legislative Audit.

Section 3. The following appropriation shall be made from the newly established Hill Top Grant Fund – Fund No. 6402:

To: 6402-0503-3100: Hill Top Grant Fund; OS&C; Other Miscellaneous \$14,804.95

(Supported by Resolution No. 2024-20-5, this is a grant received from the Arkansas Rural Community Grant Program to be used to purchase a skid unit and additional turn out gear and equipment for Hill Top Volunteer Fire Department.)

Section 4. If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 5. This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.


