EMERGENCY APPROPRIATION ORDINANCE (4)

No. 2024 - 41

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO OBLIGATE AND EXPEND REMAINING ARPA FUNDS ON THE BOOKS OF THE COUNTY; AND TO DECLARE AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

Section 1. The following appropriation shall be made from the American Rescue Plan Act (ARPA) Revenue Replacement Fund No. 1006:

To: 1000-0108-1001: Courthouse; Personal Services; Salaries, Full-Time \$15,554.92

(This sum, \$15,554.92, is to reimburse County General for salaries and benefits of county employees. These funds are allowed for government service use by the Department of the Treasury in their final rule. These figures do not include Elected Officials positions or any offices that receive reimbursement funding from the State of Arkansas or other taxing agencies.)

Section 2. This appropriation will zero out the ARPA Revenue Replacement Fund No. 1006 by December 31, 2024. All other ARPA funding that has not been expended to date, has been obligated in detail in Ordinance No. 2024-5 passed in February of 2024. These remaining funds on the books will be used for the remodel costs for the Government Center building and are in Fund No. 4800.

Section 3. If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 4. Declaration of Emergency. The U.S. Treasury has mandated that any unspent ARPA funds held by this county must be obligated or expended no later than December 31, 2024, and in order to facilitate that mandate without error an emergency is declared to exist and this emergency ordinance is effective immediately upon passage by the quorum court and approval by the county judge pursuant to § 14-14-908(f).
