APPROPRIATION ORDINANCE (2)

No. 2025 - 11

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2025 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

Section 1. The following appropriation shall be made from the County General Fund No. 1000:

From: County General – Fund No. 1000	\$2,992.15
To: 1000-0400-1001: Sheriff's Department; Personal Services; Salaries, Full-Time	\$2,375.29
To: 1000-0400-1006: Sheriff's Department; Personal Services; Social Security Matching	\$181.71
To: 1000-0400-1007: Sheriff's Department; Personal Services; Retirement Matching	\$363.89
To: 1000-0400-1011: Sheriff's Department; Personal Services; Unemployment	\$71.26

(This sum, \$2,992.15, is being appropriated into the Sheriff's Department budget for 2025 to increase the SRO Supervisor to Lieutenant pay.)

Section 2. The following appropriation shall be made from the County Jail Operations Fund No. 3498:

From: County Jail Operations – Fund No. 3498	\$10,030.74
To: 3498-0418-1001: Co Jail Operations; Personal Services; Salaries, Full-Time	\$7,962.80
To: 3498-0418-1006: Co Jail Operations; Personal Services; Social Security Matching	\$609.15
To: 3498-0418-1007: Co Jail Operations; Personal Services; Retirement Matching	\$1,219.90
To: 3498-0418-1011: Co Jail Operations; Personal Services; Unemployment	\$238.88

(This sum, \$10,030.74, is being appropriated into the County Jail Operations budget for 2025 to increase the salaries of two employees within the jail.)

Section 3. If any provision or section of the Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 4. This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.


