BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

A RESOLUTION AUTHORIZING THE COUNTY JUDGE TO APPLY FOR A GRANT ON BEHALF OF VALLEY SPRINGS VOLUNTEER FIRE DEPARTMENT.

NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

WHEREAS, the Boone County Quorum Court has determined that Valley Springs Fire Department service area meets eligibility requirements necessary to apply for a grant under the Arkansas Rural Community Grant Programs; and

WHEREAS, the Valley Springs Fire Department service area has presented plans to purchase multiple sets of turnout gear for the safety of the volunteer firefighters; and


WHEREAS, the Quorum Court of Boone County, Arkansas recognizes the need for the project, concurs its importance, and supports the Valley Springs Fire Department in its efforts to proceed with the same; and

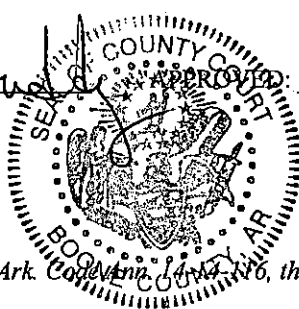
WHEREAS, the Valley Springs Fire Department has furnished proof that they have raised \$15,000.00 through community cash and/or in-kind donations to be applied to the project as a local match;


BE IT FURTHER RESOLVED, THAT THE COUNTY JUDGE OF BOONE COUNTY IS HEREBY AUTHORIZED TO SUBMIT AN APPLICATION OF FORMAL REQUEST TO THE ARKANSAS RURAL DEVELOPMENT COMMISSION FOR PURPOSE OF SECURING STATE GRANT FUNDS IN THE AMOUNT OF \$15,000.00 TO AID AND ASSIST THE VALLEY SPRINGS FIRE DEPARTMENT IN EXECUTING THE PROPOSED PROJECT DESCRIBED HEREIN AND THAT THE COUNTY JUDGE OR TREASURER OF BOONE COUNTY IS FURTHER AUTHORIZED TO ADMINISTER THE GRANT FUNDS FOR THE SAME PROJECT.
