APPROPRIATION ORDINANCE (1)
ORDINANCE NO. 2020-1

BY BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL
YEAR 2019 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR
OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE,
STATE OF ARKANSAS;

SECTION 1. The following appropriation shall be made from the County General Fund No. 1000:

FROM: 1000-0431-2002: Deputy Prosecuting Attorney; Supplies; Small Equipment \$531.43
TO: 1000-431-3003: Deputy Prosecuting Attorney; OS&C; Computer Services \$531.43

(This sum, \$531.43, is funds that were used to pay for computer services
and maintenance for the Deputy Prosecutor's Office during the months of
November and December 2019, with no new funds requested.)

FROM: 1000-0431-2003: Deputy Prosecuting Attorney; Supplies; Janitorial \$1,050.00
FROM: 1000-0431-2001: Deputy Prosecuting attorney; Supplies; General \$677.46
FROM: 1000-0416-3030: Prosecuting Attorney; OS&C; Travel \$815.73
TO: 1000-0431-3003: Deputy Prosecuting Attorney; OS&C; Computer Services \$2,543.19


(This sum, \$2,543.19, is to pay for computer services and new Server
migration for the Deputy Prosecutor's Office, with no new funds
requested.)

to such end the provisions and sections of this Ordinance are declared to be severable.


SECTION 3. This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is
