**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL
YEAR 2019 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR
OTHER PURPOSES:**

**NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY,
ARKANSAS:**

SECTION 1. The following appropriations are made from the Boone County General Fund No.
1000:

To: Establish Fund# 3501-0108-2020: Historic Preservation Grant Fund; Supplies; Building

\$60,255.89

(Boone County received a check for restoration of the exterior of the Old Federal Building, AR
Historic Preservation Grant # 19-CH-02, in the amount of \$52,615.89. Boone County also
received an AR Historic Preservation Grant # 19-CHRETT-01 in the amount of \$7,610.00 to
power wash the upper portion of the Old Federal Building. This fund was established to cover
the expenditures for the work done, with no new money requested.)

SECTION 2:

From: 3501-0108-2020; Historic Preservation Grant Fund; Supplies; Building \$6,799.89

To: 1000-0111-3100; County Buildings; OS&C; Miscellaneous \$6,799.89

(This sum, \$6,799.89, to reimburse fund 1000-0111-3100 for payment to the architect and the
grant writer for the Old Federal Historical Restoration Grant. There was \$4,824.89 paid to the
architect and \$1,975.00 to NWAEDD. There are no new funds requested.)




Section 4. This Ordinance herein enacted is an Appropriation Ordinance and therefore it is effective immediately.
