BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL
YEAR 2020 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR
OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE,
STATE OF ARKANSAS:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED THE HUMANE SOCIETY GRANT FUND.

SECTION 1. It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Humane Society's Spay and Neuter Pet Grant. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

SECTION 2. There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the Humane Society Grant with a fund number of 3503 as assigned by Arkansas Legislative Audit.

SECTION 3. The following appropriations shall be made from 3503:

To: 3503-0306-3100: Humane Society Grant; OS&C; Other Miscellaneous \$3,000.00

(This is a Spay and Neuter Grant that we applied for on behalf of the Ozark Humane Society.
This is a 50/50 matching grant.)


