For the record, this hazard pay is not retirement eligible. The county will not pay any retirement contributions on these funds)

**SECTION 2.** If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

**SECTION 3.** This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.
