ORDINANCE NO. 2021- 30

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 2021-29 OF THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2021 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

SECTION 1. The following appropriation shall be made from County General Fund No. 1000:

TO: 3034-0400-1007: Cops in School; Personal Services; Retirement Matching	\$22.69

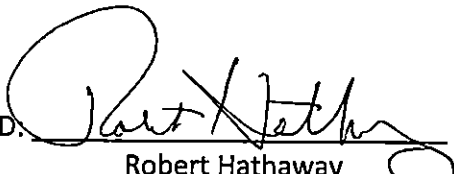

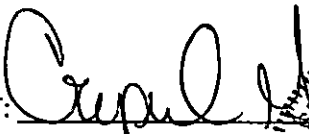
SECTION 3. This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.

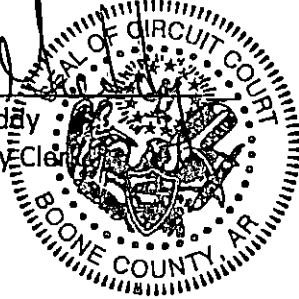
