APPROPRIATION ORDINANCE (2)

ORDINANCE NO. 2021- 31

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2021 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSE.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

**SECTION 1.** The following appropriation shall be made from County General Fund No. 1000:

TO: 1000-0400-1001: Sheriff's Office; Personal Services; Full-time Salaries	\$26,382.72
TO: 1000-0400-1006: Sheriff's Office; Personal Services; Social Security Matching	\$2,018.28
TO: 1000-0400-1007: Sheriff's Office; Personal Services; Retirement Matching	\$4,041.84
TO: 1000-0400-1010: Sheriff's Office; Personal Services; Workers Compensation	\$339.67

**COUNTY GENERAL FUND TOTAL: \$32,782.51**

**SECTION 2.** The following appropriation shall be made from Jail Operation Fund No. 3498:

TO: 3498-0418-1001: Jail Operations; Personal Services; Full-time Salaries	\$27,732.88
TO: 3498-0418-1006: Jail Operations; Personal Services; Social Security Matching	\$2,121.57
TO: 3498-0418-1007: Jail Operations; Personal Services; Retirement Matching	\$4,248.68
TO: 3498-0418-1010: Jail Operations; Personal Services; Workers Compensation	\$357.06

**JAIL OPERATIONS FUND TOTAL: \$34,460.19**

**GRAND TOTAL: \$67,242.70**

(New monies appropriated to compensate employees for county paid holidays. These funds will be used to pay employees working in areas not closed on holidays and requiring around-the-clock coverage. Employees scheduled and working on a county holiday will receive holiday pay at their current hourly rate for all hours worked. If an employee in the above referenced capacity is not working on the actual county holiday, they will receive holiday pay that is equal to a standard workday.)




**SECTION 4.** This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.
