APPROPRIATION ORDINANCE (4)
ORDINANCE NO. 2021- 33

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL
YEAR 2021 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR
OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE,
STATE OF ARKANSAS:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED THE OMAHA FIRE DEPARTMENT GRANT
2021 FUND.

SECTION 1. It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Omaha Rural Fire Department Grant. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

SECTION 2. There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the Omaha Fire Department Grant 2021 Fund with a fund number of 3504 as assigned by Arkansas Legislative Audit.

SECTION 3. The following appropriations shall be made from 3504:

To: 3504-0503-3100: Omaha Fire Department Grant; OS&C; Other Miscellaneous \$15,000.00

(This is a Rural Community Grant from the Arkansas Economic Development Commission, Division of Rural Services, that we applied for on behalf of the Omaha Fire Department.
This is a 50/50 matching grant.)


SECTION 4. If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.


SECTION 5. This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.
