APPROPRIATION ORDINANCE (1)  
NO. 2021-49

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2021 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

**Section 1.** The following appropriation shall be made from the American Rescue Plan Fund No. 3046:

To: 3025-0416-3070: Victim Witness; Other Services & Charges; Rent - Land & Buildings \$2,100.00

(This sum, \$2,100.00, is the costs incurred for the Prosecuting Attorney's Office rental space for criminal jury trials conducted in May, August, September of 2021.)

**Section 2.** The following appropriation shall be made from the Victim Witness Fund No. 3025:

To: 3025-0416-1005: Victim Witness; Personal Services; Overtime \$9,682.70

To: 3025-0416-1006: Victim Witness; Personal Services; Social Security Matching \$740.73

To: 3025-0416-1010: Victim Witness; Personal Services; Workers Compensation \$9.44

*\*No Retirement is required on lump sum payments per APERS.*

**TOTAL:** \$10,432.87

(This sum, \$10,432.87, is to pay overtime for the Victim Witness Coordinator who has accumulated 473.25 hours of compensatory time due to the drastic increase in sexual assaults to children and adults.)

**Section 3.** If any provision or section of this Ordinance is held invalid by a Court of Competent Jurisdiction, such invalidity shall not affect other provisions and sections of the Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.


**Section 4.** This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.

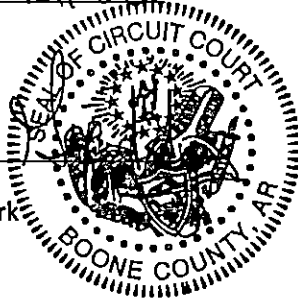
